

DOG LEASING 2017-2018 FORM- SUWANNEE RIVER FAIR

RULES:

1. Dogs participating in the Youth Dog Show must either be owned by the Exhibitor or the Exhibitor's immediate family or leased. Immediate family is defined as the exhibitor's father, mother, brother or sister.
2. The owner, hereafter referred to as the sponsor, will jointly determine with the exhibitor specific responsibilities to be carried out by each part. The responsibilities will be recorded on this Lease Agreement on the fourth page. The responsibilities and duties outline IS required for ALL leasing. These responsibilities will include such things as:
 - a. duties and responsibilities while working with the animal(s) at the home,
 - b. working schedule for carrying out the specified duties,
 - c. assistance provided to lessee by sponsor,
 - d. where will animal(s) be cared for (sponsor's or lessee's home),
 - e. who will provide feed and medical supplies,
 - f. what monetary compensation will be provided.
3. The signed Lease Agreement must be validated by the County Extension Agent or FFA Advisor and send in by no later than DECEMBER 12, 2017 (The SRF Registration late deadline) . This lease will accompany your entry form and show payment. A Florida State Fair Dog Lease Contract will also be accepted in place of this form if the dog is also competing at the state show.
4. The sponsor will make the animal(s) available to the exhibitor during the period of the Lease Agreement.
5. The sponsor relinquishes the right to train the dog in conformation, rally, obedience, agility, etc. while it is leased as a Florida State Fair dog project.
6. The sponsor relinquishes the right to show the dog in any show, conformation, rally, obedience, agility, etc. while it is leased as a Florida State Fair dog project.
7. The Lease Agreement will remain in force until the date specified by exhibitor or until terminated by either party and may be terminated prior to the specified date for reasons such as:
 - a. failure for exhibitor to carry out responsibilities as outlined in the Lease Agreement,
 - b. changes in the home operation for the sponsor.
8. All parties will sign the Lease Agreement to confirm compliance and a copy of the signed Lease Agreement will be attached to the SRF entry form.
